## Track Policy

### Rules and guidelines for those visiting the KymiRing track area.

KymiRing follows the regulations specified in its environmental permit and requires track users to carefully review the guidelines listed below. The track's operating hours and area rules must be strictly followed. The track is under camera surveillance.

- The tenant is obligated to follow these general rules of KymiRing as well as environmental regulations. If the user fails to comply with the regulations, KymiRing has the right to immediately suspend track usage and cancel the reservation of the driving time.
- KymiRing has the right to point out any identified safety concerns and require immediate action. The event may be suspended, and the tenant's activities on the KymiRing motorsport track area may be prohibited if the tenant does not comply with the rules or instructions. The tenant is responsible for any damage they cause.
- If KymiRing suspends the tenant's activities based on the reasons mentioned above, the tenant is not entitled to a refund or compensation from KymiRing for any financial losses that may result from the suspension.
- KymiRing has the right to charge for any additional costs incurred due to the tenant's failure to fulfill their obligations or negligence.
- The tenant is responsible for all personnel and activities in the pit and track area. The tenant is obligated to familiarize themselves with the instructions for handling accidents. The tenant is responsible for the individuals participating in the event and ensuring they are instructed on the accident handling instructions. In case of an accident, individuals must report it immediately to the event organizer, who is required to notify

KymiRing's staff. A responsible person must always be designated for events, and their contact information must be provided to KymiRing.

- The tenant is responsible for any damage that may be caused by their activities to the track area or equipment, whether to KymiRing or a third party. If the tenant causes damage to the asphalt, curbs, barriers, the track itself, or any other property, they are obligated to fully compensate for the damage incurred.
- The tenant must agree in advance with KymiRing if there is a need to construct additional structures during the rental period, such as wiring or scaffolding. These must be carried out in a way that does not damage the track or any structures in the area. They must also not interfere with any other activities taking place in the area.
- We require the validity of traffic insurance or other equivalent insurance.
- The tenant must provide a preliminary event schedule, the number and type of participating vehicles, and the group division at least two (2) days before the event begins.

### **Noise Restrictions and Measurements**

- The noise restrictions are in accordance with the technical regulations of Suomen moottoriliitto (SML) and AKK Sports, and are based on international standards. Vehicle noise levels are measured before driving, and access to the track area will be denied if a vehicle exceeds any of the allowed limits. During driving, vehicles exceeding the noise level limits may have their session interrupted.

### **SML Motorcycle Noise Limit and Noise Measurement**

- The permitted noise limit for Circuit Racing motorcycles is 107 dB/A. The noise measurement method is based on a constant engine speed – measurement procedure: The microphone must be placed 50 cm away from the exhaust outlet of the silencer at a 45-degree angle, primarily in a horizontal direction, but at least 20 cm above the ground. During the noise

measurement, the rider must be on the motorcycle in a normal riding position. No other persons, apart from the measurer and the rider, are allowed to be in the immediate vicinity of the event. During the measurement, the rider gradually increases the revs until the designated RPM for the motorcycle is reached. At that point, the meter reading is recorded. Measurements are conducted at each exhaust outlet.

- The following table applies to noise measurements in Circuit Racing for engine RPMs:

Engine RPM at the time of measurement:				
RR four-stroke engines	1 syl	2. syl	3.syl	4.syl
< 600 cc	5 000	5 500	6 500	7 000
600 – 750 cc	5 000	5 500	6 000	7 000

**The AKK speed competition rules, Section 9.10, regarding noise reduction:**

- The maximum allowed noise level is limited to 110 dB(A).  
The measurement is conducted using an A-scale "slow" setting, with the sound meter placed 50 cm away from the exhaust outlet at a 45-degree angle, while the vehicle is running at 4500 RPM. For specific classes and categories, lower maximum values may apply.

**Track area guidelines**

- The maximum allowed number of vehicles at same time on the KymiRing GP track is 40 cars or 50 motorcycles.
- In the motorsport center, vehicle use is permitted during the following times: the motorsport track is open Monday to Sunday from 9:00 AM to 6:00 PM, except for vehicles registered for road use, which are allowed from Monday to Sunday from 9:00 AM to 8:00 PM. However, competitive

driving activities are only allowed from 9:00 AM to 6:00 PM. Any use between 6:00 PM and 8:00 PM must be agreed upon separately.

- Any form of competition on the track is prohibited during track days or private events.
- For half-day bookings, driving time is from 9:00 AM to 1:00 PM in the morning and from 2:00 PM to 6:00 PM in the afternoon. The lessor may conduct a safety and condition inspection of the track during the booking, and maintenance actions will be carried out if necessary.
- The pit and track area must be kept clean. The motorsport track area must be returned to its original condition after the rental period ends. KymiRing is responsible for ensuring that the rental facilities and tracks are in a basic usable condition and ready for the tenant's use at the start of the rental period.
- Waste generated in the area must be placed in the designated containers. The waste bins are labeled and sorted by type and category. Contact the staff if the waste includes hazardous materials. For example, used tires must not be left in the area. For larger events, waste management and costs will be negotiated on a case-by-case basis. Each tenant is responsible for ensuring that the area is cleaned of trash and waste after the event. Additionally, any tires or vehicle parts that have detached from the track area must be removed.
- KymiRing may charge separately for electricity, waste, and wastewater costs based on the number of event participants and the requirements of the event. In such cases, matters to be agreed with KymiRing before the event include, among others, cleaning, the management of WC and social facilities during the event, the use of indoor spaces, and associated costs. The use of the pit garages or pit area must always be reserved and agreed separately. The WC and shower facilities located in the pit building are available for the tenant's use during the track booking.

- Any machinery, items, or equipment borrowed or rented from KymiRing must be agreed separately, and they must be returned to their proper locations in an approved condition.
- Smoking is only allowed in designated smoking areas. Cigarette butts must be disposed of in the designated containers.
- The use of intoxicants is prohibited. Alcohol is only permitted in designated drinking areas.
- Hot work operations are only allowed in designated areas and by individuals holding a valid hot work license.
- Washing of vehicles, their transport equipment, and track maintenance equipment outside of the designated washing area is prohibited.
- Track users must bring their own fuel and supplies in their own transport containers. Fueling and vehicle maintenance must be carried out in the oil separation area of the pit building. Absorbent mats must be used under vehicles when necessary.
- In exceptional emission and disturbance situations, as well as accidents that may pose a danger or harm to the environment or health, the user must immediately take action to prevent emissions and their associated damage. The staff will provide guidance on the location and use of environmental damage control equipment and supplies. KymiRing's oil spill response equipment includes, among other things, oil booms, absorbent materials, and storage facilities required for oil waste. In the case of an oil spill incident, KymiRing will promptly begin corrective measures using its own equipment and, if necessary, notify the emergency services.
- Only authorized personnel are allowed to be in designated areas of the track, and any unauthorized presence is prohibited. The tenant is responsible for controlling access during their event on the motorsport track area and ensuring that unauthorized individuals do not enter the area. The movement of the lessor's own staff may not be restricted.

- Overnight stays on the track area are not permitted without explicit permission from KymiRing. The tenant is responsible for nighttime supervision between 8:00 PM and 7:00 AM, as well as any actions and costs related to overnight stays, including those concerning personnel and fire safety.
- Use extreme caution when moving around the track area; you do so at your own risk. Pay attention to the use of mobile devices to avoid creating emergency situations for yourself or others. Remember that activities in the area can be loud: use hearing protection to prevent hearing damage. We do not recommend bringing small children or pets to the area. In the pit area, individuals under 16 years old are only allowed with an adult.
- The speed limit in the pit area is 10 km/h. Parking is only allowed in designated areas. Access to the track area and pit lane is prohibited for outsiders. The speed limit on the pit lane is 30 km/h.

### **Safety guidelines**

- The tenant is responsible for obtaining the necessary permits and agreements with the police, emergency services, first responders, and environmental authorities. The tenant must coordinate with emergency services regarding the required rescue and equipment needs. A first response unit and/or an emergency medical unit, as well as a fire truck, if necessary, can be arranged through KymiRing. All safety arrangements must be agreed upon with the lessor/safety manager no later than three (3) weeks before the event begins.
- Depending on the event, it is possible that the police and emergency authorities may request a rescue plan. Therefore, the tenant must provide details of the event to the lessor no later than three (3) weeks before the event begins. The tenant is responsible for providing any required documentation and plans to the authorities.

- For small events, the tenant must, upon request, create a safety and rescue plan for the event they are organizing and submit it to the lessor at least five (5) days before the event.
- The tenant is also responsible for securing the necessary permits for the event, as well as arranging for security personnel, traffic controllers, traffic guides, and event signage and notifications. Traffic plans, signage to be installed along the roads, their removal, and all related permits are the responsibility of the event organizer.
- A rescue plan for the track area has been created in cooperation with the emergency services and can be provided upon request.
- During events, KymiRing has access to the track area's surveillance cameras, and track operations can be controlled from the control room in coordination with the tenant, as separately agreed. The tenant can rent track personnel from KymiRing if needed. The tenant is responsible for ensuring that there are enough officials on-site. In case of an accident, driving will be halted, and KymiRing will handle any necessary track repairs.
- The staff is trained in first aid, and in the event of an accident, emergency services will be alerted to the site. The tenant or event organizer is responsible for ensuring that the resources meet the requirements of the event.
